In this model, citizens visit the official web-portals of government to access the various types of services. This model strengthens the bond between government and its citizen. Payment of online bills, Online passport registration etc. are the examples of services included in this model.

Ans: Following are some of the important characteristics of a Good Governance:

- 1. Good governance is answerable to the community for its decisions.
- 2. Good governance is transparent.
- 3. Good governance follows the rule of law.

- 5. Good governance is effective and efficient in implementing decisions that make the best use of the available resources.

Ans: E-Governance stands for Electronic Governance. It refers to the use of ICT to improve the range and quality of information and services delivered to the public. E-Governance has made the working of government more transparent. Models of E-Governance:

- 1. Government to Citizens (G2C): This model refers to the government services which are shared by citizens. For Example: Payment of online bills, Online passport registration etc.
- 2. Government to Business (G2B): This model refers to the government services which are shared by businessmen. For Example: Collection of taxes, Payment of bills etc.
- 3. Government to Employees (G2E): This model refers to the government services which are shared by its employees. For Examples: Employees can access any kind of rule-regulation, Employees can check their payment and records etc.
- 4. Government to Government (G2G): This model refers to the government services which are shared between the governments. For Example: Sharing of information between police department of various state etc.
